Staff Report: Bruce Eddy presented staff report contained in packet.

Education/Planning Committee: G. Thompson reported

Presentation: Children's Services Fund of Jackson County CEO Rob Whitten, provided an overview of the fund, history, current activities and future goals. 13.2 million anticipated to fund 5 areas of focus annually: temporary shelter, family intervention, counseling, healthy lifestyles, and suicide prevention. Currently funding 87 projects; 25% school based. Jackson county residents, birth through 19. Tax sunsets in 7 years, back on ballot in the next 4 years.
