| <u>Presentation: Jennifer Craig,</u> <u>ReDiscover, CEO</u> | T.Cummings | ReDiscover's CEO Jennifer Craig presented an overview of the 988 mental health crisis hotline. J.Craig reported that 988 is a 3-digit number similar to the concept of 911. The intentionality behind 988 is to help people that need mental health care receive quick access. The goal is for 988 to be rolled out nationwide by July 16, 2022. Board discussion followed. | Information: Roadmap to the Ideal Crisis System |
| Cultural Competence Advisory Council (CCAC) Update | T.Cummings, R.DePriest | T.Cummings reported that the CCAC met on 22-Sep-2021 with more discussion about the piloting of the star-rating system tool. The SRS tool was piloted with two agencies (Jewish Vocational Services (JVS) and Truman Medical Center Behavioral Health) so that both the agency and the CMHF can make improvements to ensure that language is clear and that use of the SRS tool is easily understood. R.DePriest reported that this process is working in both JVS and Truman. The process was comprehensive and use of the SRS tool has been transparent. Tool can be tailored to agencies' mission and vision, and their indiviudal need for improving diversity, equity, inclusiveness, and cultural competence. | information |

| DeLaSalle 2nd Quarter Report | R.Harris, R. DePriest | R.Harris reported that the DeLaSalle pilot project was delayed in getting started and that they're currently requesting technical assistance from the CMHF. R.DePriest reported that DeLaSalle has completed the foundational aspects of their organization, and that DeLaSalle is now currently organizing and developing their services, therapists, and providers. R.DePriest will continue working with DeLaSalle in-person at a near-by future date. | information |
| Special Populations Site Reviews - Emailed September 8th, 2021 | R.Harris, S. Jones | R.Harris reported that Special Populations site reviews were emailed. R.Harris noted that all Special Populations agencies were meeting compliance. S.Jones reported that behavioral health positions were having difficulty becoming filled, particularly credentialed positions (therapists, etc). Agencies' VBP work leads to examining aspects that affect wait list and access; case loads and how they're managed, etc. Although though there may be staff shortages, VBP activities focus on management of case loads and staffing. Staff shortages were prevelant prior to COVID-19, and it has continued to worsen. This is a current challenge for most CMHF-funded organizations. | information |
