Program: 988 Update. Report: Value- Based Payment (VBP) Review	R.DePriest	Jennifer Craig from ReDiscover reported on the new 988 Suicide & Crisis Lifeline. Formerly known as the National Suicide Prevention Lifeline, this service helps thousands of people overcome crisis situations every day. The lifeline provides 24/7, free and confidential support to people in suicidal crisis or mental health-related distress. The goals of 988 include: a strengthened and expanded Lifeline infrastructure to respond to crisis calls, texts, and chats anytime, and a robust system that provides the crisis care needed anywhere in the country. 988 presentation slides can be accessed here. Board discussion followed. R.DePriest reported that the Value-Based Payment committee met 31-Aug-2022 on Zoom to examine possible methodologies on how the value-based payment program will allocate incentive funds to the CMHF-funded agencies. For the last few weeks, CMHF staff has met with Cohorts 1 and 2 agencies within the VBP initiative to gear them up to "play" the value-based payment program. CMHF staff has started to educate Cohort #3 agencies on what value-based payment is and how the program will work.	information
